Notice of the demand for arbitration shall be delivered personally or by mail to all other parties to the dispute whether they be Lot Owners or the Homeowners' Association.

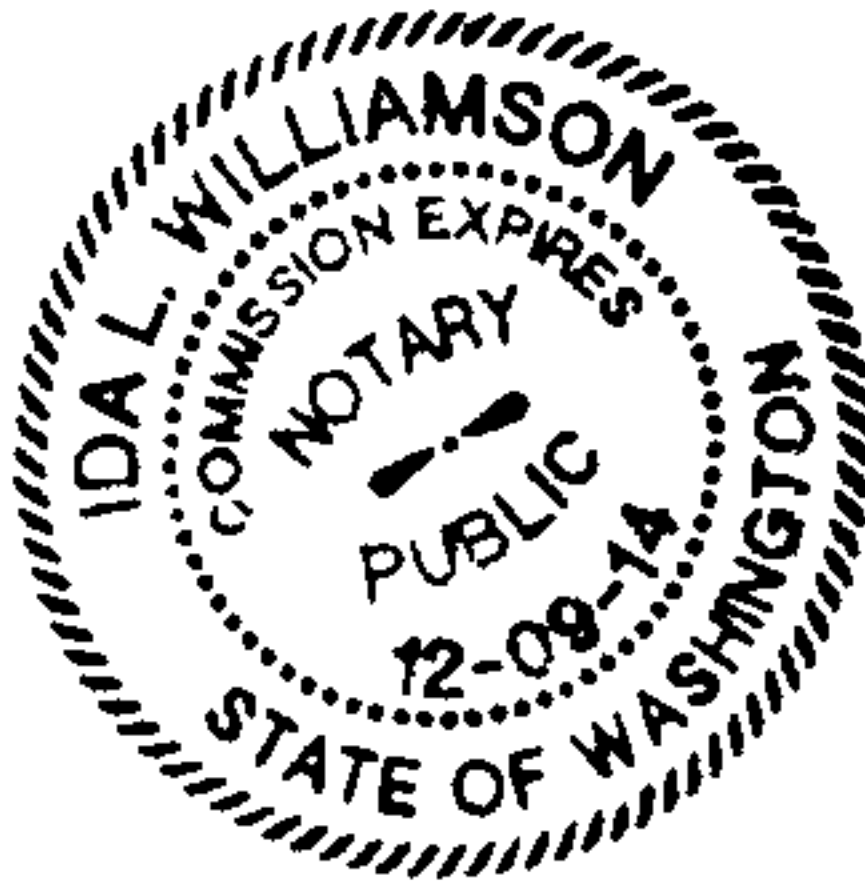
